<u>Report on the Compliance of the Directions</u> <u>given by the Appellate Tribunal for Electricity in its Order dated 27th January,</u> <u>2012 in Review Petition no. 5 of 2009 in Appeal No. 181 of 2008</u>

This report contains the status of the implementation of the directions given by the Hon'ble Tribunal to the Secretary of the Forum of Regulators in its Order dated 27th January, 2012 in Review Petition no. 5 of 2009 in Appeal No. 181 of 2008.

As directed by the Hon'ble Tribunal, the State Electricity Regulatory Commissions (SERCs) and Joint Electricity Regulatory Commission (JERCs) of the concerned States where there were vacancies in Consumer Grievance Redressal Forums (CGRFs) along with those States where the posts of CGRFs and Ombudsman are yet to be created were requested by the FOR Secretariat to send the updated status in this regard. Further, it was also requested telephonically to ensure submission of the relevant information by the due date.

The report is divided into five sections dealing with the following directions given by the Tribunal:
